A. AWARDS & RECOGNITION		
INDIVIDUAL CATEGORIES		
1.	Criminal Justice Award	Awardees (attorneys or legal service providers) must have either directly represented victims in criminal, juvenile, or appellate courts or worked to promote or implement policies to improve the treatment of victims in the criminal justice system.
2.	Access to Justice Award/Human Rights Lawyer of the year	- Awardees must be human rights defenders working towards the protection and promotion of human rights. - The Award celebrates excellence and outstanding achievement in human rights, whose determination and dedication made an exceptional contribution to the promotion, protection and advancement of human rights.
3.	Juvenile Justice Award	Awardees must be active members of the bar who devote a significant portion of his/her legal practice to youth and children and is/are making positive contributions to the field both in and outside the courtroom.
4.	Legal Education Excellence Award	Awardees must be law professors with a mission to promote excellence in legal education, serving as communities of interest in scholarship, teaching and service, whose excellence in scholarship, teaching or community service has made a significant contribution to promoting public understanding of law, justice and fairness in the legal and justice system, or best practices on the part of lawyers and judges.
5.	Difference Maker Award (recognizes lawyers and non-lawyers)	Multiple sub-categories: (a) Making a Difference through Pro Bono Work Award - honours an individual attorney or non-attorney, who made a difference in the local community with a commitment to enhance access to justice. (b) Making a Difference through Pro Bono Work Award - honours law firm/corporate legal department/government attorney office/institution - outstanding commitment to volunteer legal services for the poor and disadvantaged. (c) Making a Difference by Breaking Barriers - honours an attorney, living or deceased - broke barriers for gender/disabilities/migrant workers, etc. (d) Making a Difference through Service to the Profession - honours attorneys, living or deceased - significant contribution to the profession (frequent activities in bar associations, committees, and services). (e) Making a Difference through Community Service - honours attorneys living or deceased - significant lifetime contribution to the local community through community service (not necessarily through pro bono work).
6.	Legal Education Outreach Award	Honours outstanding public service and law-related education programs.

7.	Woman Lawyer of the Year Award	- Awardees must be women lawyers who have achieved significant results either in business or for the benefit of the society. - Awardees must have created or provided opportunities otherwise unavailable to women, inspiring other women lawyers to pursue a career in law.
8.	Ismail Wisham Up-and-Coming Lawyer Award	Awardees must demonstrate troubleshooting and legal skills; client satisfaction; leadership; strategic vision; and contribution to the wider community.
9.	Sole Practitioner of the Year Award	- Awardees must be sole practitioners who have had a profound impact on the lives of their clients. - Entries must convince the Award Committee that they are not only leaders in their chosen areas, but that they have made significant progress over the past 12-18 months.
10.	Mentor of the Year Award	This award aims to celebrate the importance of mentoring in the profession by highlighting a person who has supported an individual throughout the year to help them achieve success in the profession or has a track record of mentoring people throughout their career.
11.	Lifetime Achievement Award	This award recognizes legal services of at least 25 years standing, whose legal services and advocacy has, during a distinguished career, significantly advanced the rights of the wrongfully injured, and who by substantial service to the legal profession, has significantly furthered the cause of justice and the mission of the profession.
GROUP CATEGORIES		
12.	Pro Bono Award (Institutions Category)	Honours institutions in the legal profession that have demonstrated outstanding commitment to volunteer legal services for the poor and disadvantaged.
13.	Pro Bono Program of the Year	Recognizes the pro bono Program which had the biggest impact on enhancing access to justice in the past year.
14.	Public Service Award	Recognizes the works of lawyers/law firms/legal practices that help tell the story of the Maldives Justice System and rewards the creative achievements and contributions of lawyers that lead to a more effective and responsive law, justice and public administration system.
15.	Wellness Initiative of the Year	Recognizes the programs introduced by lawyers at law firms, legal practices etc., fostering wellness in the workplace.
16.	Law Firm of the Year Award	- Awardees must be law firms who have had a profound impact on the lives of their clients. - Entries must convince the judges that they are not only leaders in their chosen markets but that they have made significant progress over the past 12-18 months.
17.	Distinguished Service Award	The Distinguished Service Award recognizes members of the Bar Council of Maldives/partner organizations/other institutions and organizations who during the past year have been of special assistance to the Bar Council.
18.	Certificate of Recognition	This certificate recognizes outstanding service to the Bar Council of Maldives through assistance with event management, fundraising, membership engagement, or developing the Bar Council's programs in the past year.
